### 1.1 Chair's Report

### 1.2 Treasurer's Report (Kim)

- Chequing Account: $\$ 3,907.60$ (HANDOUT - 2016/17 School year report)
- Gaming Account: $\$ 2,987.18$ (Present). Expecting gaming grant which should be approx. $\$ 4,380.00$. This would take us up to $\$ 7,367.18$

A motion was put forth by Jen Popoff to pay the remainder of the Aquavan fee (we had already agreed to pay $\$ 800.00$ at a previous meeting) $\$ 600.00$; Holly Mackie Second this motion. Population vote was also taken and all were in favour of paying for the Aquavan.

2) Increased classroom numbers even with a decreased enrolment because of the change in the teacher's contract. This has lead to teacher's having more say in class size and composition. New teachers hired because of the classroom number increase which also leads to a smaller number of students in each room.
3) Water : Drilled well is 85 ft deep instead of the original 200 ft that was mentioned. As of now IHA says water is okay, but they are pushing for treated water. The district can expect to pay approx. $\$ 100,000.00$ for either the UV or the Chlorinated water treatment system they decide to put in.

PAC reviewing plans for a filtered water fountain. Concern is with the water's present heavy metal content and that it may wreck not only the new fount, but the school's water infrastructure. It already damages the taps. It is in the best interest of PAC's investing to wait until the system (well) is in and then decide what to do - fountain, bottled water, etc?
